- ask the full name of the organization
- check their mission and how the money will be spent





- ask what percentage of donations go directly to relief and not overhead
- listen to your instincts
- always give a check payable to the organization, never to an individual
- avoid giving cash
- check if they are a registered charity (they must be in Florida) by calling (800) 435-7352 or www.800helpfla.com
- donations are tax deductible if given • to credible charities so ask if the donation is tax deductable
- don't be pressured....need help or been scammed? Call Justice & Consumer Service at 464-6200.

New Year Happy to While most of the evervone! local units are jumping into the second half of the year, revising the budgets and looking at possible Founders Dav а there is program, another matter that really needs to be attended to now - forming a Nominating Committee! If this has not been done already, it is imperative that it happen at the next General Meeting. The committee needs time to carefully formulate a slate of officers.

Please remember a few things. The Nominating Committee consists of a group of people who are elected at a General Meeting. The local unit bylaws will state how many should be on this committee. which is an odd number. Once the committee is elected, the President will appoint а Chairman pro tem, who will call the first meeting. At that meeting, a chair is elected by the committee, to preside over the meetings. (Remember that the President may NOT serve on this committee, and people who have served the year before, may not serve again for a year.)

The job of the Nominating Committee is to provide a slate of officers with one person position for the in each Committee. The Executive Executive Committee usually consists of the President, Vice President(s), Secretary, and Treasurer. These are the officers who need to be elected. Please remember that the night of the election, people may run from the floor (as long as the person has been a member of that PTA for 30 days), so the Nominating Committee cannot "stack" an election. They only choose people who they feel will do a good job, and form the slate. The slate of officers must be presented at one General Meeting with at least 30 days between the presentation and the election. to aive the membership time to review this.

One other element is very important. The night of the election, a complete membership roster should be available. If any position has another person running from the floor, only people who are members may be given a ballot to vote. Therefore, this is also а good time to make sure the membership list is complete and up to date. Remember that your membership dues should have been sent into the State Office by 1/31/10 to be current.

Thanks for all that you continue to do for the children of Florida! It remains our privilege to serve with all of you!

YOURE CHILD'S VISION: IF YOU CANNOT SEE YOU CANNOT LEARN

What Parents Need to Know

Good vision is essential to every child's development. Experts say over 80 percent of what a child learns in school is presented visually, so making sure your son or daughter has good vision can make a big difference in their academic performance.

Routine eye exams for children can detect many problems, including nearsightedness, farsightedness and/or astigmatism. These can be promptly treated with eyeglasses or contact lenses. Routine exams are also needed to make sure your child's eyes are healthy and to rule out amblyopia, strabismus and other binocular vision problems that may interfere with your child's vision development, academic performance and sports vision.

15 million people in the United States have serious vision problems; over 500,000 people in the US are blind. More than one in fifty children have Amblyopia, and one in twenty preschool children have an eye problem that could lead to amblyopia (Prevent Blindness America 2005). The good news is that amblyopia detected within the first six years of life is treatable.

Every child should have a good vision screening prior to starting kindergarten. This screening can be performed by a pediatrician, a trained volunteer, or an eye care professional (ophthalmologist or optometrist). Only an eye care professional can provide a complete eye exam, which is more complete and detailed compared to a vision screening.

After starting school, all children in kindergarten and grades 1, 3, 6 have their vision checked annually at school, but this is not as comprehensive an exam as performed by an eye doctor.

What is Amblyopia?

Commonly known as Lazy Eye, Amblyopia is the number one cause of blindness in children age 0-5 years. Amblyopia results as a misalignment of a child's eyes; as one eye becomes stronger, it will take over, and the weaker eye will often lose function. Amblyopia may be present in straight eyes as well and only a vision test will detect the problem. With early diagnosis and treatment, the weaker eye can regain its full function (Prevent Blindness America 2005). Parents are often unfamiliar with or unaware of the warning signs of amblyopia, allowing the problem to go undiagnosed, resulting in blindness. As the child continues to age, the vision impairment becomes permanent and untreatable.

What are the signs of lazy eye?

Many different problems can cause lazy eye. Here are some signs of eye trouble that could be related to lazy eye or other eye problems:

- Favoring one eye
- Tilting the head
- An eye drifts or wanders when the child is tired, sick or in bright light
- Your child tends to close one eye, especially in sunlight
- Rubbing the eyes
- Your child seems to blink too much
- Your child holds things close to his or her eyes

If you notice these or other signs of eye trouble, contact your school nurse or take your child to an eye doctor right away. Some children with eye problems may show no signs of eye trouble, so a periodic eye exam is recommended.

Vision impairments involve more than just eyesight. Vision impairments can also hinder a child's ability to learn. Many times children are misdiagnosed with Attention Deficit Disorder (ADD/ ADHD) when, in reality, they have poor visual processing.

According to Margaret Livingstone from the Department of Neurobiology, Harvard Medical School and the Dyslexia Research Laboratory, poor visual processing can play a significant role in a large majority of children who struggle to read. Children who cannot see well due to a need for vision correction fail to pay attention and perform poorly in school (Children's Visual Information Network 2007). Without being able to see the board or read papers in front of them their ability to learn is hindered. Diagnosing visual impairments or processing problems early can help a child to be able to reach their full potential, rather than being misdiagnosed and treated for the wrong disability.

Eye injuries account for 4% of the cases of blindness. Here are some tips about eye safety..

- Walk, don't run, with sharp objects such as scissors, pens, pencils and rulers.
- Avoid guns, bow-and-arrows, sling shots and firecrackers.
- Use good lighting to avoid tiring your eyes when reading, writing or cruising the Internet
- Learn basic first aid for your eyes in case an injury does occur.
- Tell your parents, school nurse or teachers if your eyes are bothering you.
- Wear proper eye protection when you are doing hazardous hobbies, chores or mixing chemicals.
- Wear proper eye protection when you are playing sports such as racquetball and baseball. According to the National Society to Prevent Blindness, the leading cause of sports-related eye injuries in:
 - 5-14 yr. olds is baseball;

- 15-24 yr. olds is basketball;

- Wear sunglasses that block both ultraviolet-A and ultraviolet-B radiation from the sun.
- Never look directly at the sun.
- Point chemical sprays away from your face BEFORE spraying.
- Wear a helmet when biking, skateboarding or rollerskating and wear your seatbelt in the car
- It is also a good idea to get your eyes examined regularly. Your body has some "built-in" devices to protect your eyes such as:
- Bony sockets: your eyes are located in bony sockets to protect them from getting hit.
- Eyebrows: your eyebrows are

used to keep the light out.

- Eyelids: your eyelids can close to keep small objects out of your eyes.
- Eyelashes: eyelashes also keep small objects out of your eyes.
- Tears: tears keep your eyes moist and work to wash small objects out of your eyes.
- Blink reflex :the blink reflex automatically closes your eyes.

Interesting Factoid:

The word "pupil" comes from the Latin word "pupa" that means "doll." The use of the word pupil for the center of the eye may have come from the observation that if you look into the eye of another person, a small version of yourself (a "doll") is reflected back.

If a child needs a visual evaluation, please contact your school nurse. We are fortunate that we have several community partners to assist us when we have students that need follow-up for poor vision. Lenscrafters' One Sight Vision Van and their Hometown Day programs in Dec. 2009 assisted 243 students to be evaluated and receive new The Glazer glasses. Family Foundation and the Tampa Bay Buccaneers will be partnering with the Vision Quest Corp. to also provide exams and glasses for students that meet the qualifica-Spring tions starting this in Pinellas County. We also have certificates for qualified students to see local eye doctors and get free through alasses а national program called VSP through the National Association of School Nurses. The local Lion's Clubs also offer assistance. It is important that we help every child meet their full potential- and if you cannot see- you cannot learn!

Go online to <u>www.ESEsurvey.com</u> to complete the survey.

Results?

Survey results are reported to the United States Department of Education, Office of Special Education Programs, as part of Florida's Annual Performance Report and are posted on the Florida Department of Education's Web site at <u>www.fldoe.org/ese</u>.

Improvement activities are determined based on the survey report. Progress is monitored through the annual parent survey. No names will be released in any report. All responses are confidential.

What Can You Do?

The responses to the survey provide important information for planning and monitoring improvement activities. This survey, conducted only once a year, provides parents with a unique opportunity to be heard. This year's survey deadline is **July 1, 2010.**

SAFETY HARBOR ELEMENTARY ALL PRO DADS!

Here at Safety Harbor Elementary we are nearly busting our buttons with the pride we have for our All Pro Dads program. This is our first year starting an APD chapter at our school, and when it was suggested we add this program to our already busy PTA schedule, I was a little hesitant. Finding a chairperson, a Dad, of course, would be a challenge. Or so I thought. Last February, 2009, at our Kindergarten Grandparents Day program, I recognized a Dad having lunch with his kindergarten son. Eric Johnson was a face I recognized from my church. I approached Eric to see if he would be interested in chairing an APD chapter at our school for the next school year. He was a little nervous, being a new dad to the school but agreed.

Over the summer Eric logged on to the Family First website that gave all the information necessary to start All Pro Dads at our school. He set his first meeting for September. I helped him along by introducing him to our Librarian, Principal, and Cafeteria manager all of whom he would be working with to plan monthly morning breakfast meetings. He emailed dads he knew and sent flvers home school-wide. Then Eric did what he does best... he started talking with all the other dads he saw as he dropped his son off at 1st grade nearly every day. I was told by other schools not to expect more than 10 dads and their kids at the first meeting. But we were hopeful that in time All Pro Dads would be a success in teaming Dads with their kids at school.

Eric kept me updated as to how many dads showed a positive response to coming to the meeting. His enthusiasm and love for his kids overflowed and he was thrilled when he boasted he had 25 dads confirmed for the next morning's meeting. Our principal, Bob Kalach along with teachers and PTA were exciting awaiting the dads and kids.

When I arrived at school the next morning, there were no parking places to be found. I weaved my way into the crowded cafeteria with the line out the door. I was greeted by our assistant principal, Mary Jane Gordon, who enthusiastically told me there were over 70 dads in attendance along with their children, that made about 140! Our cafeteria manager was a little frazzled serving breakfast to the hungry group, but somehow she fed them all. When I finally found Eric in the sea of smiling dads and happy children, we were both speechless.

Since September Eric has kept his attendance record at about 60 dads per monthly breakfast meeting. His uplifting emails and genuine friendship to his dads keeps them connected and motivated to be better fathers. Eric has scheduled off-site events such as putt-putt and bowling. Another dad in the group offered to organize flag football on the school grounds after school on Thursdays, while other dads help with flyers. When Eric found two dads that worked at the Coast Guard Station, he jumped at the chance to schedule an educational tour for the group. On Dec. 12th they were able to see the inside of a C-130 airplane and a J-Hawk rescue helicopter. The dads and kids learned that the Coast Guard does much more than search and rescue missions. More importantly, our dads and kids have forged relationships with the school, PTA, and with each other that will positively affect them for a lifetime.

Our PTA looks forward to many more years of success with our All Pro Dads chapter. And to think it all started with just asking one dad to be a PTA volunteer.


Florida PTA Receives National Honor for Advocacy Efforts
